

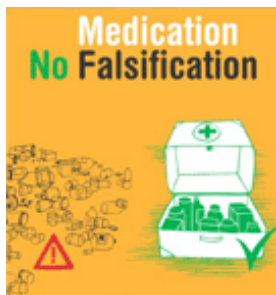

618 arrests, 1 death, 4.4 million fake pills, 45 illegal pharmacies or stores closed and 600,000 counterfeit condoms seized... a sad record reached the 3rd quarter of 2015. IRACM compiles the global news issued on fake and falsified / counterfeit medicines during the last three months, and the IRACM key initiatives.
